## 23rd Which Way to go?

They say that the government of Britain is the cause of the failing of housing where as everyone know there is a huge shortage because of the big demand for the very little available houses.

This off course has contributed to the massive increase in house prices and in the rent. It has really and truly because an affordable for the key workers to find a house to buy and the same goes for the young people who buy their first time property.

But, even though I agree that the last government and the last mayor of London have failed to build enough houses to reduce the shortage of availability of houses, this can't be the only reason.
